Pistol Purchase Permit General Information

It is the responsibility of the applicant to know the laws & regulations regarding the use & storage of a firearm.

An applicant must be 18 years of age to obtain a pistol purchase permit; however the applicant must be 21 years of age to purchase a firearm from a federally licensed dealer.

Permits to purchase a handgun in North Carolina must be obtained from the Tyrrell County Sheriff's Office and the cost for each permit is \$5.00.

Applicants Must:

- must be 18 years of age
- have obtained a residency in Tyrrell County for 30 days
- must provide a current driver's license with a valid address
- Resident Aliens: must bring a resident alien card, social security card and a North Carolina driver's
- Naturalized Citizens: must bring your Naturalization Certificate or valid US Passport

APPLICANTS MUST NOT:

- 1. Must not have been convicted of any felony, or similar offense in any jurisdiction or currently under incitement for any felony offense.
- 2. Fugitive from Justice
- 3. Unlawful user of/or Addicted to Any Controlled Substance
- 4. Adjudicated as mental defective or Have Been Committed to a mental institution
- 5. Be Aliens and be Illegally or Unlawfully in the United States
- 6. Dishonorable Discharge (DC) or Dismissal from the Armed Forces
- 7. Renounced Their Citizenship
- 8. Subject to a court order that restrains them from harassing, stalking, or threatening an intimate partner or child of such intimate partner, or from engaging in other conduct that would place the partner or child in reasonable fear of bodily injury.
- 9. Convicted in any court of a Misdemeanor Crime of Domestic Violence
- 10. Under Indictment or Information for a Crime Punishable by imprisonment for a Term Exceeding One Year
- 11. Must not have unresolved criminal charges pending.
- 12. Must not have a substantial history of convictions, arrest or report demonstrating a continuing pattern of criminal activity.

NOTE: As part of the application process you will authorize the Tyrrell County Clerk of Superior Court to inform the Tyrrell County Sheriff's Office whether or not the clerk's records contain the any record of involuntary mental commitment proceeding under Article 5 Chapter 122C of the General Statute.

§North Carolina General Statute 14-315.1. Storage of firearms to protect minors.

- (a) Any person who resides in the same premises as a minor, owns or possesses a firearm, and stores or leaves the firearm (i) in a condition that the firearm can be discharged and (ii) in a manner that the person knew or should have known that an unsupervised minor would be able to gain access to the firearm, is guilty of a Class 1 misdemeanor if a minor gains access to the firearm without the lawful permission of the minor's parents or a person having charge of the minor and the minor:
- (1) Possesses it in violation of G.S. 14-269.2(b);
- (2) Exhibits it in a public place in a careless, angry, or threatening manner;
- (3) Causes personal injury or death with it not in self defense; or
- (4) Uses it in the commission of a crime.
- (b) Nothing in this section shall prohibit a person from carrying a firearm on his or her body, or be placed in such close proximity that it can be used as easily and quickly as if carried on the body.
- (c) This section shall not apply if the minor obtained the firearm as a result of an unlawful entry by any person.
- (d) "Minor" as used in this section means a person under 18 years of age who is not emancipated. (1993, c. 558, s. 2; 1994, Ex. Sess., c. 14, s. 11.)

DISQUALIFYING CRIMINAL OFFENSES PURSUANT TO N.C.G.S. § 14-41S.12(b)(8)

An individual who has been adjudicated guilty of or received a prayer for judgment continued or suspended sentence for offenses constituting a misdemeanor under the following specific statutes, or other crimes of violence, is disqualified from obtaining a permit to carry a concealed handgun:

- 1. Harassment of and communication with jurors (14-225.2)
- 2. Violating orders of court (14-226.1)
- 3. Furnishing poison, controlled substances, deadly weapons, cartridges, ammunition or alcoholic beverages to inmates of charitable, mental or penal institutions or local confinement facilities (14-258.1)
- 4. Weapons on campus or other educational property (14-269.2)
- 5. Carrying weapons into assemblies and establishments where alcoholic beverages are sold and consumed (14-269.3)
- 6. Carrying weapons on state property and courthouses (14-269.4)
- 7. Possession and sale of spring-loaded projectile knives (14-269.6)
- 8. Impersonation of fireman, emergency medical services personnel (14-276.1)
- 9. Impersonation of law-enforcement or other public officers (14-277)
- 10. Communicating threats (14-277.1)
- 11. Carrying weapons at parades and other public gatherings (14-277.2)
- 12. Stalking (14-277.3)
- 13. Stalking (14-277.3A)
- 14. Throwing or dropping of objects at sporting events (14-281.1)
- 15. Exploding dynamite cartridges and bombs (14-283)
- 16. Riot and inciting to riot (14-288.2)
- 17. Fighting or conduct creating a threat of imminent fighting or other violence (14-288.4(a)(1))
- 18. Making or using any utterance, gesture, display or abusive language that is intended and plainly likely to provoke violent retaliation and thereby create a breach of peace (14-288.4(a)(2))

- 20. Assault on emergency personnel (14-288.9)
- 21. Violations of city State of Emergency Ordinances (14-288.12)

SUPPLEMENTARY QUESTIONS FOR APPLICANTS FOR A PERMIT TO PURCHASE A HANDGUN

Prohibitions applicable to certain aliens. Federal law makes it unlawful for aliens who are illegally or unlawfully in the United States to receive or possess firearms. In addition, subject to certain exemptions, aliens who are in a non-immigrant status are prohibited from possessing or receiving firearms in the United States.

A non-immigrant alien is not subject to this prohibition if the alien:

- 1) Is in possession of a valid hunting license or permit lawfully issued in the United States;
- Is an official representative of a foreign government who is accredited to the United States Government or his or her government's mission to an international organization having its headquarters in the United States; or
- 3) Has received a waiver from the prohibition from the Attorney General of the United States. See 18 USC 922(y)(2) for additional exceptions. In order to determine whether applicants who are not U.S. citizens are prohibited from possessing firearms under Federal law, it is necessary to obtain answers to the following questions.
